After a lawsuit, the courts ruled that the school had to admit blacks or provide equal accommodations; thus the opening of Lincoln University Law School in St. Louis for Blacks. In 1943, Mrs. Wilson became the second woman to graduate from the school and the second African-American woman to pass the bar in Missouri. She would go on to campaign tirelessly for those who faced discrimination in our world, regardless of race or economic disadvantage.

Eunice Kennedy Shriver passed away at the age of 90, a tireless advocate for the powerless and disabled. In 1987 at the Special Olympics world games in South Bend Indiana, Mrs. Shriver stated: "The right to play on the playing field? You have earned. The right to study at any school? You have earned. The right to hold a job? You have earned. The right to be anyone's neighbor? You have earned it." Sounds like an excellent rallying cry to me, not only for the intellectually disabled, but for anyone with a goal of improving their lives and in turn, improving the world as a whole.

It was said that Eunice Kennedy Shriver was a woman who got things done. Now that there is a void, I encourage you to pick up the torch, crawl through the window, or bust down the door, and make a difference.

Though this year is half way over, AWL has already achieved many fabulous successes. Our social/community support gatherings have been an overwhelming success. # Missouri Enacts Data Security Law

On July 9, 2009, Governor Nixon signed House Bill 62 (“HB 62”), making Missouri the 45<sup>th</sup> state to adopt a data breach notification statute which went into effect August 28, 2009. This bill amends the Merchandising Practices Act and is notable because it applies not only to those providing goods and services to Missouri consumers, but also to any company, regardless of size or nature of business, that maintains or possesses records or data containing personal information of Missouri residents.

“Personal information” includes an individual’s first name or first initial and last name in combination with any one or more of the following:

- Social Security Number;
- Driver’s license number or other unique identification number created or collected by a government body;
- Financial account number in combination with required password or access code;
- Unique electronic identifier or routing code in combination with required password or access code;
- Medical information; or
- Health insurance information.

This new law requires that in the event a third party gains unauthorized access to and unauthorized acquisition of personal information maintained in computerized form that compromises the security, confidentiality or integrity of the personal information (a “breach of security”), the company must provide notice to the Missouri resident immediately following discovery of the breach. The notice must include, at a minimum:

- A description of the incident in general terms;
- The type of personal information obtained in the breach;
- The general acts of the business to protect the personal information from further unauthorized access;
- A contact number that the affected person may call for further assistance;
- Contact information for consumer reporting agencies; and
- Advise the affected person to monitor account statements and credit reports.

This notice may be in writing, by telephone or via electronic mail. Substitute notice, which shall consist of an internet posting or notification to major statewide media, is appropriate only where 1) the cost of providing notice would exceed \$250,000; 2) the class of affected people to be notified exceed 500,000; 3) the company lacks sufficient contact information; or 4) the class of affected residents is unidentifiable. A willful and knowing violation of this law may result in civil penalties up to \$150,000 per breach.

In light of these changes to the law, companies should take stock of the personal information they possess, and incorporate the appropriate notices and procedures in their business plans.

## WEN Success Story

Wanda Coleman is a past graduate of the Women’s Employment Network (WEN) and now a successful mother of four boys (19 year old twins boys who are in college, an 18 year old boy getting ready to enter college in the fall, and a 5 year old boy with special needs) and a full-time employee at DST Systems, where she has been employed for the past eight years.

Wanda moved to Kansas City after a tour in Desert Storm to be with her husband and then three children. She had no family here and was going to school full-time and doing her best to earn a degree with help from the G.I Bill. Her husband watched the children while she went to school and worked full-time to pay the bills. One day after returning home from school, her husband was gone without any notice. Wanda found herself in an unfamiliar city, with no one to turn to, no job to support her or her family, and without knowing where to turn.

Not knowing if the program was right for her, or if it would help, she decided to give it a try. She came to WEN lost, confused, and scared, but determined to push forward through her circumstances not only for herself; but also for her three young boys. Over the course of five weeks, WEN helped change her mind and made her realize that if she wanted something, she could achieve it. They helped her identify skills she didn’t know she had, helped her develop a resume, and gave her connections to resources that she didn’t know existed. Over time, she became more self confident and independent.

According to Wanda: “If you give a woman a fish ( i.e. welfare, food stamps, etc . ) she can eat for a day or two; but if you teach a woman to fish ( i.e. give her the tools she needs to be successful in life) she will eat for years and years to come.” This is what WEN did for not only Wanda; but for her children as well.

Wanda is just one of the more than 5,000 women who have gone through WEN’s program and who are now strong, self-sufficient, and independent women in our community earning a living and providing not only for themselves, but also for the families that depend on them.

## 2009 AWL Step Up Provides Legal Services to Over 200 Women

Kansas City Municipal Court judges, prosecutors, and staff, along with 52 volunteer attorneys, resolved nearly 650 outstanding tickets for women in area shelters during the AWL Step Up Program on July 9, 2009. More than 200 women left municipal court with smiles and countless words of appreciation for the attorneys and judges who served them. Unpaid traffic tickets, which turned into outstanding warrants, caused problems for these women when applying for jobs and accessing important services to move on with their lives.

“AWL Step Up gives these women a boost at a rough time in their lives,” said John B. Williams, a Kansas City Municipal Court Judge, adding, “I was impressed by the number of volunteer lawyers who don’t usually appear in Municipal Court.”

Step Up was initiated to assist women in area shelters by providing much-needed free legal assistance to help dispose of outstanding warrants and charges in the Kansas City Municipal Court. The program allows Step Up participants, who cannot afford to pay the tickets and attorney fees, to substitute community service for court costs and fines. Local shelters and service agencies referred women to Step Up, including: Hope House, Rose Brooks, Synergy, Safe Home, New House, Operation Breakthrough, and MOSAICS.

The volunteers had varying degrees of experience in municipal court – for some it was their first time, while others appear there daily. Aubrey Gann-Redmon goes to municipal court frequently but described Step Up as a different experience from her usual day-to-day. “The Step Up Program is an excellent reminder of the oath an attorney takes to serve those who need it most, and I was humbled by my clients, who were brave enough to leave their abusers and show up in court with the

intention of tying up loose ends so that they could embark on a new chapter in life. It was inspiring!” Gann-Redmon said that one of her clients had multiple citations for driving with a suspended license. “We were able to get all but one dropped, and rather than having to pay a fine, she received a Suspended Imposition of Sentence with community service.”

Volunteer attorney Theresa Levings was glad to finally par-

ticipate in the program this year, saying “I will look forward to next year’s program and will encourage other AWL members to take part.”

“It’s a good program for people who simply do not have the means to hire an attorney, pay fines, and must continue to drive legally,” said Paige Waits, who participated in the event with her father, attorney Dennis Waits.

Jennifer McAdam and her father, Judge Michael McAdam,

also participated together for the second year. “As a civil attorney, I don’t usually have an opportunity to visit my dad in municipal court. I like that we can both give back to the community and make a difference in people’s lives,” Jennifer said. “I’m very happy to be associated with a volunteer project that helps so many women in need and allows me to work with great people from AWL,” explained Judge McAdam.

In 2007, Step Up won a Public Service Award from the National Conference of Women’s Bar Associations. The program has grown and improved every year since it began in 2006. Committee members are working with the municipal court to make the project run even more smoothly next year. “To provide better service to the women, we will need to cut off registration 48 hours before the event and not allow walk-in participants,” explained Mira Mdivani.

The Step Up Committee, consisting of AWL Past President Janeen deVries, AWL Board Members Mira Mdivani and Beth Murano, and AWL members Jennifer McAdam and Samara Nazir Zaman, with the help of the general membership organized the volunteers and coordinated with area shelters and the municipal court.

## Jennifer McAdam

### New Member Profile

Jennifer McAdam may be a new member to AWL, but she has already proven to be an asset to our organization with her participation in the Shelter Step-Up Program two years in a row. Jennifer is also one of ten participants in the inaugural class of AWL Connections, a mentoring program designed to create social and professional connections between newer attorneys and those with more experience. Active involvement and a volunteering spirit is nothing new to Jennifer - she has been involved and interested in social justice and welfare issues since she attended Kansas University as an undergraduate. (In fact, judging from her family ties – see below – we suspect the proclivity toward community involvement may be in her genes!)

While earning her degree in Sociology and American Studies, Jennifer volunteered with women's and children's causes. She worked with women's shelters and disabled adults during her college years. After graduating, Jennifer's interests progressed to the policy side of social welfare programs. She lobbied Topeka legislators for several years on behalf of women's and children's organizations, including Planned Parenthood and Kansas Action for Children.

Her work as a lobbyist led Jennifer to law school and her husband's new job took them to New York. Jennifer attended and graduated from the Benjamin Cardozo School of Law. While attending law school, Jennifer interned for a United States District Court Judge for the Eastern District of New York. Luckily for the Midwest, however, Jennifer and her husband decided to return to their roots and came back to the Kansas City area after graduation.

Jennifer's first position was as a law clerk to the Honorable Ronald Holliger. After completing her clerkship, Jennifer joined Lathrop & Gage, LLP in September, 2008. Jennifer practices in the firm's Insurance Recovery and Business Litigation department.
